



**Bicycle Pub, LLC's VEGAS PUB CRAWLER - Liability Waiver  
and Behavioral Guideline Agreement**

1. As participant and/or rider I fully acknowledge the risks involved on the *VEGAS PUB CRAWLER* as an open and obvious danger. By signature of this agreement, I hereby permanently release, indemnify, and hold harmless Bicycle Pub, LLC from liability of personal injury or damages sustained to myself or any third party during my tour.
2. I acknowledge that my participation in activities revolving around *VEGAS PUB CRAWLER* whether as a participant or observer is completely voluntary and I personally assume all said risks.
3. I further agree to indemnify and hold harmless Bicycle Pub, LLC, or any party acting on behalf of Bicycle Pub, LLC for any attorney fees and/or costs incurred as a result of litigation.
4. I am 21 years of age or over.
5. Bicycle Pub, LLC has my permission to use my photograph, video and audio recordings, likeness, artwork, profile and/or story in this and future publications, web pages and other promotional materials produced, used by and representing Bicycle Pub, LLC. I understand the circulation of the materials could be worldwide and that there will be no compensation to me for this use.

**Behavioral Guideline Agreement**

I hereby agree to comply with **all** of the following behavioral guidelines:

1. I agree that NO alcohol is permitted on *VEGAS PUB CRAWLER* while on the public right-a-way. Violation of this rule of the City of Las Vegas will result in your immediate removal from *VEGAS PUB CRAWLER*.

2. I agree to carry all beverages in a plastic container/ bottle. I agree to not carry any glass and/or ceramic containers on *VEGAS PUB CRAWLER*.
3. I agree to comply with all directions conveyed by the *VEGAS PUB CRAWLER* Designated Driver. I acknowledge that the driver has full authority to end any tour for cause at any time based on behavioral guidelines non-compliance.
4. I acknowledge that the *VEGAS PUB CRAWLER* Designated Driver and employee is the only person allowed to drive *VEGAS PUB CRAWLER*.
5. I acknowledge that the driver has full authority to deny any rider/participant use of *VEGAS PUB CRAWLER* based on his/her non-compliance of the behavioral guidelines included but not limited to the following:

**Belligerence, Public Intoxication, Littering, attempting to get on, or jump off *VEGAS PUB CRAWLER* while it is in motion**

6. After the *VEGAS PUB CRAWLER* Designated Driver, the primary cardholder on file is in command of stop lengths and reloading times. Any delay in a timely return of *VEGAS PUB CRAWLER* will be charged to this person's credit card per the Late Return Policy.
7. I agree to be mindful and respectful of all residents and agree to keep noise to a reasonable level at all times, particularly in residential areas.
